**NOTIFICATION - 14/2017**

In supersession of Notification no. 02/2012, dated 27.11.2012 regarding schedule for registration and payment of examination fee for Secondary and Senior Secondary Courses examinations, the revised schedule will be effective from October-2017 Examinations onwards.

The same has been revised in the light of reducing the number of days for the examinations due to combination of subjects and also in view of the preponement of the declaration of the result. The revised scheduled would be as under :

**(A) FOR APRIL PUBLIC EXAMINATIONS**

- (i) For fresh and unsuccessful learners of previous examinations - 21<sup>st</sup> November to 20<sup>th</sup> December (without late fee)
- (ii) For learners who have been unsuccessful in the preceding examinations i.e. October Examinations - 1<sup>st</sup> December to 20<sup>th</sup> December (without late fee).
- (iii) For all learners with late fee of Rs.100/- per subject - 21<sup>st</sup> December to 31<sup>st</sup> December (with late fee)
- (iv) For all learners with consolidated late fee of Rs.1500/- per learner - 1<sup>st</sup> January to 10<sup>th</sup> January (with consolidated late fee).

**(B) FOR OCTOBER PUBLIC EXAMINATIONS**

- (i) For fresh and unsuccessful learners of previous examinations - 21<sup>st</sup> May to 20<sup>th</sup> June (without late fee)
- (ii) For learners who have been unsuccessful in the preceding examinations i.e. April Examinations - 1<sup>st</sup> June to 20<sup>th</sup> June (without late fee).
- (iii) For all learners with late fee of Rs.100/- per subject - 21<sup>st</sup> June to 30<sup>th</sup> June (with late fee)
- (iv) For all learners with consolidated late fee of Rs.1500/- per learner - 1<sup>st</sup> July to 10<sup>th</sup> July (with consolidated late fee).


